



Instructions for Completion of the KDHE Checklist for Risk Management Plan Review

1. The Medical Care Facility Risk Manager will complete all of the fields/ elements in blue and/or marked with an asterisk. The KDHE Checklist for Risk Management Plan Review will be the coversheet for the Risk Management Plan that must be submitted annually to KDHE as the licensing agency in its entirety a minimum of 60 days prior to the renewal of the medical care facility licensure with KDHE.
 - a. This includes the Year of the Plan
 - b. The Name and ID/ CCN of the Medical Care Facility
 - c. The Physical Address Location of the Medical Care Facility
 - d. The Name of the Risk Manager
 - e. The Page Location(s) for each Content Element

2. Upon completion of the review by the KDHE Risk Manager, any 'Not Met' content elements will be communicated to the Risk Manager for additions/ changes/ deletions, as applicable.
3. Upon re-submission by the Medical Care Facility Risk Manager, a re-review will be completed by the KDHE Risk Manager to make a final determination.
 - a. If the submitted RMP has all of the required content elements, the Risk Management Plan (RMP) will be approved for the year and not impede renewal of the medical care facility licensure.
 - b. If the submitted RMP will not be approved for the year, then the renewal of the medical care facility licensure will not be possible until the RMP is approved.
4. Note: The submission of the Risk Management Plan is to be completed no later than 60 days prior to the renewal of the medical care facility licensure. The preferred timeframe is 90 days prior to licensure renewal. This timeframe is to allow for review and adjustments as necessary prior to the licensure expiration.

Additional note: Your Governing Body approval is one of the required elements. This approval is required prior to KDHE submission for KDHE Risk Manager Review.
