Single-Family Home, Owner-Occupied

The Kansas Department of Health and Environment can help you address Lead-Based Paint Hazards in your home for **FREE** in order to prevent lead poisoning in young children. A state-certified risk assessor will inspect your home and determine the services needed to stabilize the lead-based paint in your home. State-certified lead abatement contractors will perform all work.

You may qualify if:

- ✓ You own and occupy a home in Wyandotte County that was built before 1978. Primary consideration will be given to the following zip codes: 66101, 66102, 66103, 66104, 66105, 66106, 66111, and 66112.
- ✓ Your household income is less than or equal to 80% of the area's median income (see Income Table on page 4).
- ✓ You have a child **up to 6 years of age** who lives in your home or visits your home more than **10 hours every week**.
- ✓ For at least 5 years following lead hazard work on your property, you agree **NOT** to sell the property. **SHOULD YOU BREACH THIS AGREEMENT BY SELLING THE PROPERTY WITHIN 5 YEARS, YOU SHALL REIMBURSE A PERCENTAGE OF THE EXPENDED REMEDIATION FUNDS, BASED ON A SLIDING SCALE, TO KDHE.**

If you answered, "YES" to all of the above, complete the following:

- All portions of the application form. **Sign and date** the application form in Part D.
- Attach copies of **Proof of Income** from all adults living in the household. (Most recent income tax returns)
- Attach a copy of **Proof of Ownership** of your home. (Deed or property tax statement)
- Attach a copy of **Proof of the Year the House was Built**. (Wyandotte Co. Appraiser)
- Attach a copy of the **Birth Certificate** for each child under the age of 6.
- All Children up to age 6 must have a **recent blood test for lead** before work can begin on the property. (Blood lead tests obtained within 6 months of the application date are acceptable.)
- Mail or deliver** the application form and all required documents to the Project Lead-Safe Office (see address above).
- Attach a copy of your Drivers License or Birth Certificate, BPU bill, gas bill, and telephone bill.**

*Disclaimer: KDHE reserves the right to withdraw from this project at any time if the applicant does NOT meet any of the following: 1) Did not supply the required information for a complete application; 2) it is determined that construction costs will exceed 50% of the County appraisal; 3) the overall condition of the property is deemed "unsafe" for lead hazard control work to be completed; or 4) the applicant has not complied with Project Lead Safe KCK's Program Policy and Procedures.



Common Questions

How do I determine when my home was built?

If you need proof of when your home was built, please contact the Wyandotte County Appraiser's Office at **8200 State Avenue**. The phone number is **913-287-2641**. Just ask for a printout showing the year the house was built. There is no cost to obtain this printout, which may also serve as proof of ownership.

Where do I go for proof of home ownership?

If you want to obtain a copy of your most recent property tax statement to submit as proof of ownership, please contact the Wyandotte County Treasurer at 913-573-2823. There is no charge to obtain this record.

What do I do to get my child tested for lead? Call your doctor or clinic. If you do not have a doctor, call our office at 913-262-0796 for the next free testing date.

How do I get a copy of my child's birth certificate?

If you need a birth certificate for a child under age 6, please contact the state where the child was born. If the child was born in Kansas, you can get an application form at the Project Lead-Safe KCK office. Application forms must be sent to the KDHE Office of Vital Statistics, 1000 SW Jackson, Suite 120, Topeka, KS, 66612-2221. The cost is \$12 for one copy and \$7 for each additional copy of the certificate.
