

<p>Completing the Flow Sheet Care Plan for an Infant When I complete the Flow Sheet Care Plan for a new infant, do I complete it for 6 months or for a year?</p>	<p>The care plan on the flow sheet tab should be completed at the time of the certification visit for the entire period including the next recertification (if appropriate). This procedure includes the full year for infants – not just to the midcertification.
