HINI INFLUENZA PARTNER CONFERENCE CALL FROM FRIDAY, NOVEMBER 6, 2009

Deputy Director of Health Report

The very good news is that the HINI vaccine supply really is increasing! Kansas was allocated just over 115,000 doses the week of Nov. 2, which is actually a little more than was projected.

In light of the increasing vaccine supply, when will local health departments need additional vaccinators? KDHE is trying to gauge demand for vaccinators as one of the triggers for recommending the declaration of a disaster emergency. If local health departments are planning clinics and think that you will need to recruit additional vaccinators, please send KDHE an e-mail at HINIfluinfo@kdheks.gov.

Dr. Thomas R. Frieden, Director, Centers for Disease Control and Prevention (CDC), sent a letter to all state and local health officers, reinforcing the importance of the continuing efforts to focus on the science-based priority groups recommended by the Advisory Committee on Immunization Practices. Dr. Jason Eberhart-Phillips, State Health Officer, asked that KDHE remind everyone again about making sure that health departments are reaching out to children with underlying neurologic conditions who are at high risk for HINI. Please work with pediatricians and other health care providers to assure that these children are vaccinated.

Finally, KDHE wants to note that the state is receiving surge capacity assistance from two highly qualified CDC public health professionals. Jimmy Keller, an experienced public health advisor stationed with the Florida State Health Department, arrived Mon. Nov. 2, and is hard at work assisting staff in the KDHE operations center. Dr. Joseph Prejean, an epidemiologist with the CDC HIV/AIDS program, arrived Mon., Nov. 9, to reinforce the Epidemiology and Surveillance staff. KDHE wishes to thank both of these gentlemen and CDC for their assistance.

Vaccination Campaign Report

The Kansas Immunization Program (KIP) HINI Vaccination Campaign Report for Fri., Nov. 6 includes the following information. Please click the image on the left to view the full report.

- Vaccine Target Groups, and Recommendations - the ACIP and KDHE recommend that the following subset of the initial target groups are **high priority** for vaccination **until vaccine availability increases:**

- a Pregnant women
- b Persons who live with or provide care for infants less than 6 months of age (parents, siblings and daycare providers, etc.)
- c Healthcare and emergency medical services personnel who have direct contact with patients or infectious material
- d Children 6 months through 4 years of age
- e Children and adolescents 5-18 years of age who have medical conditions that put them at higher risk for influenza-related complications, click the image for information on "Children with Developmental Disabilities, and Chronic Medical Conditions."



See the KIP report for the five expanded target groups and applicable vaccine to administer.

- Vaccine Distribution updates on the Kansas plan for HINI provider enrollment and vaccine distribution; local health department weekly HINI vaccine allocation amount; instructions on placing orders due to Veteran's Day, Nov. 11; manufacturer specifics on vaccine returns; and ancillary supply kit details.
- Vaccine Providers -
 - a CDC has stated that every provider administering vaccine should sign a provider agreement whether they get the vaccine directly from the distributor through an approved order, as a vaccine transfer from the local health department, or from a parent organization such as a hospital.
 - b Please enroll Vaccine for Children (VFC) providers in your area and approve vaccine orders as soon as possible since they can help access children with underlying medical conditions. If you do not know who the VFC providers are in your area, please contact Erica Hutton at ehutton@kdheks.gov.
- Vaccine Administration, Recommendations and Documentation includes - dosing of children 9 years and younger; pneumococcal polysaccharide vaccine information and updated CDC-related documents; CRA reported doses administered; revisions to the Influenza Vaccination Record card; screening questionnaires for both live attenuated influenza vaccine (LAIV) and inactivated influenza vaccination documents.

OPERATION UPDATES

Community Mitigation Team Highlights

The National Association of County and City Health Officials (NACCHO) is conducting weekly H1N1 sentinel network surveys to better understand the impact of H1N1 on local health departments and the jurisdictions they serve. Summary information from the survey will be shared with CDC and other policymakers to help guide decisions; results from the weekly survey will also serve as an additional mechanism to compile best practices on H1N1.

The intent of the weekly survey is for local health departments in NACCHO's Sentinel Network to provide information about non-pharmaceutical and other interventions related to the H1N1 influenza pandemic. The survey is sent out every Tues. and requests information about situational awareness and interventions conducted from Sun. through Sat. of the previous week.

The initiative includes two survey tools. The first, available in its entirety [here](#), includes questions on the following topics: situational awareness of influenza like illness (ILI) outbreaks, closures, and re-openings; recommended ILI-related non-pharmaceutical interventions (NPI); health outcomes; impact of ILI on health care facilities; and H1N1 vaccine. The second survey tool, available [here](#), focuses on H1N1 vaccination activities, vaccine availability, communication strategies and CDC H1N1 calls with NACCHO members.

There are currently 137 health departments participating in the sentinel network, which is six more sites compared to Oct. 9th, when NACCHO distributed demographic information about the network. At that time, there were 131 health departments representing 36 states. The Association of State and Territorial Health Officials (ASTHO) will share the complete listing once it is available.

ASTHO is working with NACCHO to receive updates and results from the weekly surveys and more information will be included in the ASTHO 'Daily H1N1 Updates' as it becomes available. Please email any questions to infocenter@astho.org.

Antiviral Medication and Personal Protective Equipment Briefing

Significant progress is being made in registering facilities for the Kansas Antiviral Dispensing Program. As of Thurs., Nov. 5, contracts have been signed by 22 safety net clinics, 38 hospitals, and 172 retail pharmacies. KDHE is now working to have other interested facilities sign contracts and enroll in the Kansas Countermeasure Response Administration (KS-CRA) system. Facilities are submitting completed contracts and CRA user agreements to Sonia Jordan at BPHP. KDHE is currently planning CRA training for antiviral sites, which will be conducted on or before Fri., Nov. 13. An initial distribution of Tamiflu 75 mg formulations will be shipped to CRA-registered pharmacies beginning on Fri., Nov. 13. This initial distribution will be followed up by a redistribution campaign of the antiviral medications distributed by KDHE in Apr. KDHE will be seeking the assistance of local health departments and other facilities where antivirals are being stored in those redistribution efforts. This assistance will likely be in the form of transportation of material from current storage sites to the newly recruited participating facilities for dispensing.



KDHE recently asked hospitals to report their preferred models, availability, and rate of consumption of N95 respirators. This was in an effort to determine levels of need within facilities for N95 supplies. KDHE would like to remind facilities to follow current CDC guidance on conservation of respirators as part of an overall hierarchy of controls to prevent influenza transmission. Additionally, hospital preparedness regions have varied levels of N95 stockpiles that need to be accessed and depleted prior to requests for Strategic National Stockpile (SNS) supplies. KDHE is finalizing a respirator and mask protocol to be used by facilities when ordering from the state. It should be noted that KDHE has limited model numbers of respirators available and may not be able to fill all requests being made.
