In July 2007, Florence Crittenton presented her with the second annual agency "hero" award for her advocacy work on behalf of Kansas children. In 2003-4, President Bush appointed her as one of 13 national experts to represent parents of children with mental illness to the New Freedom Commission on Mental Health.
