



KANSAS STATE LOAN REPAYMENT PROGRAM

2019 FACT SHEET

The Kansas State Loan Repayment Program (SLRP) offers eligible health care professionals an opportunity to receive assistance with the repayment of qualifying educational loans in exchange for a minimum two-year service commitment to provide health care services at an eligible practice site in a federally designated Health Professional Shortage Area (HPSA). The SLRP awards are made annually for up to \$25,000 for physicians and dentists and up to \$20,000 for all other professionals. After the initial contract has been fulfilled, the professional may apply for a contract continuation, in one-year increments, for up to three additional years of service. **The SLRP funds are to be used as an annual one-time lump sum payment toward eligible student loans and do not replace regularly scheduled loan payments.**



OTHER ELIGIBILITY REQUIREMENTS

- Professional must be a US Citizen or National
- Professional must have current permanent Kansas professional license
- Professional must work full time at an approved practice site
- Practice site must be public or non-profit entity
- Practice site must be in a federally qualified HPSA
- Practice site must accept Medicare and Medicaid
- Practice site must charge for services at usual and customary rates prevailing in the area for services
- Practice site must have a sliding fee scale or charge no fee for those unable to pay
- Practice site must have a written non-discrimination policy
- Practice site must provide services in a culturally and linguistically appropriate fashion
